Obligation Report for East-West Gateway Council of Governments

As required by 23 CFR 450.334, Metropolitan Planning Organizations (MPOs) are required to publish a listing of projects for which federal funds were obligated in the previous fiscal year. The following report details projects that obligated federal funds in Madison, Monroe, and St. Clair Counties in Illinois, and Franklin, Jefferson, St. Charles, and St. Louis Counties and the City of St. Louis in Missouri. This report documents federal funds obligated by the Illinois Department of Transportation (IDOT), Missouri Department of Transportation (MoDOT), local public agencies, Bi-State Development/Metro, and Madison County Transit District (MCTD). By definition, 'obligated' means that federal funds were authorized and committed by the State or designated recipient, and authorized by the Federal Highway Administration (FHWA) or awarded as a grant by the Federal Transit Administration (FTA). In some cases, FHWA funds are transferred to FTA. Once they are transferred to FTA for a transit project, the funds are administered as FTA funds and take on all the requirements of the FTA program.

This report documents the flow of federal funds in the region for federal fiscal year 2023 (October 1, 2022 – September 30, 2023) and was compiled based on information received from partner agencies including MoDOT, FHWA-Illinois Division, Metro, and Madison County Transit District. Within each agency a unique identifier or sponsor number is given to a project. The MPO identification number is called a TIP number. Projects can also be identified by the title and description of the improvements. These projects are listed on the following pages.

Appendix A – Definition of 23 CFR 450.334

§450.334 Annual listing of obligated projects

- (a) In metropolitan planning areas, on an annual basis, no later than 90 calendar days following the end of the program year, the State, public transportation operator(s), and the MPO shall cooperatively develop a listing of projects (including investments in pedestrian walkways and bicycle transportation facilities) for which funds under 23 U.S.C. or 49 U.S.C. Chapter 53 were obligated in the preceding program year.
- (b) The listing shall be prepared in accordance with §450.314(a) and shall include all federally funded projects authorized or revised to increase obligations in the preceding program year, and shall at a minimum include the TIP information under §450.326(g)(1) and (4) and identify, for each project, the amount of Federal funds requested in the TIP, the Federal funding that was obligated during the preceding year, and the Federal funding remaining and available for subsequent years.
- (c) The listing shall be published or otherwise made available in accordance with the MPO's public participation criteria for the TIP.

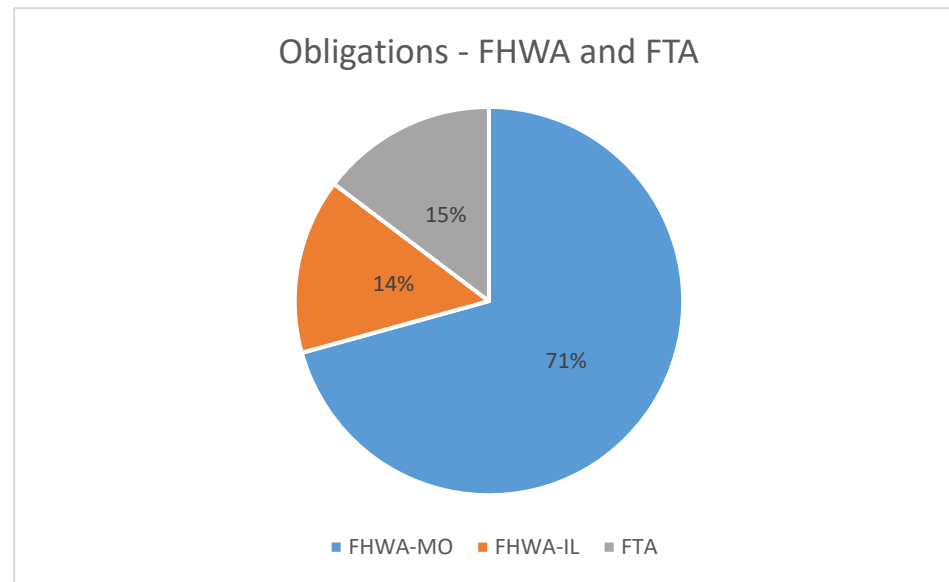

Advance construction is a technique that allows a state DOT to initiate a project using non-federal funds while preserving eligibility for future federal-aid funds. After an AC project is authorized, the state may convert the project to regular federal-aid funding provided federal funds are made available for the project. This practice is used in anticipation of future federal funds. This list shows the amount expected to be convert to federal funds (Future Federal Cost).

Appendix C – Summary of Obligations

The following pages provides a summary of obligated projects by state and funding type. For the entire region in FY 2023, \$722 million in federal funds were obligated with \$510 million in FHWA funding in Missouri, \$105 million in FHWA funding in Illinois (including advance construction), and \$106 million in bi-state FTA funding (including Bi-State Development/Metro, Madison County Transit District, and senior/disabled transit service providers).



MISSOURI - FHWA

Of the \$510 million of the FHWA funds in Missouri that were obligated, \$399 million were for MoDOT projects while \$111 million were for local projects. Projects are categorized by main project type (preservation, safety, congestion, access to opportunity, sustainable development, and goods movement). While projects may contain multiple project types (i.e. preservation and safety), this analysis focuses on the main priority area of the project. In Missouri, \$236 million (46%) of projects were for preservation of existing system, \$13 million (3%) for operational and safety improvements, \$252 million (49%) for congestion improvements, \$8 million (2%) for sustainable development type projects (i.e. sidewalks, bike paths, etc.), and \$2 million (<1%) for goods movement projects. There were no obligations for access to opportunity projects. Approximately \$233 million were obligated for an I-55 capacity improvement project in Jefferson County, resulting in an unusually high percentage of funds being used for congestion improvement projects. In typical years, preservation projects make up approximately 70% of funds. The following two tables detail the breakdown by sponsor and by project type.



ILLINOIS - FHWA

Of the \$105 million of the FHWA funds in Illinois that were obligated, \$88 million were for IDOT projects while \$17 million were for local projects. Projects are categorized by main project type (preservation, safety, congestion, access to opportunity, sustainable development, and goods movement). In Illinois, \$91 million (87%) of projects were for preservation of existing system, \$1 million (1%) for operational and safety improvements, \$7 million (7%) for congestion improvement, \$4 million (3%) for sustainable development type projects (i.e. sidewalks, bike paths, etc.) and \$3 million (2%) for goods movement projects. There were no obligations for access to opportunity projects. The following two tables detail the breakdown by sponsor and by project type. AC funded projects are included in these totals since the projects were obligated. Federal funds will be converted at a later date.



FTA

Of the \$106 million of the FTA funds that were obligated \$104 million were for Bi-State Development, \$1 million were for Madison County Transit and \$1 million were for senior/disabled transit service providers. Projects are categorized by main project type (preservation, safety, congestion, access to opportunity, sustainable development, and goods movement). For FTA projects, \$98 million (92%) of projects were for preservation of existing system, \$2 million (2%) for safety improvements, and \$6 million (6%) for access to opportunity projects. There were no obligations for congestion, sustainable development, or goods movement projects. The following two tables detail the breakdown by sponsor and by project type.
