

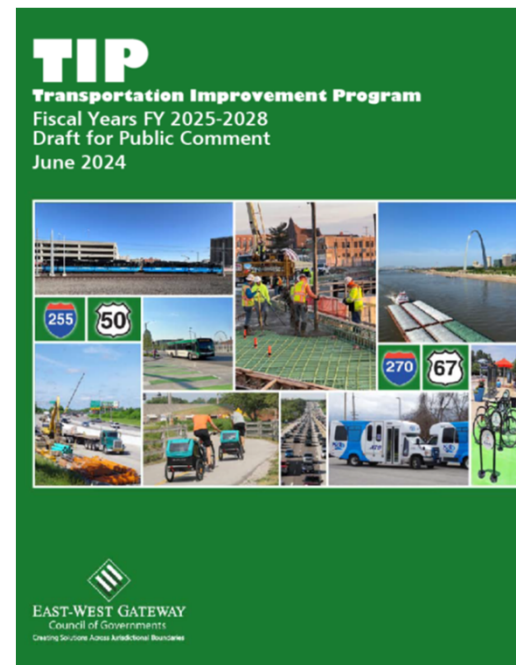

Transportation Improvement Program (TIP)

- Annually updated program of projects
- Projects must be included in the TIP to access federal funds
- Includes description of projects, total cost, and federal funds proposed to be obligated
- Board adopted policies utilized to develop the document
- Demonstrates fiscal constraint



Total Program

- 857 projects at a total cost of approximately \$6.05 billion
- 169 new projects / 688 reprogrammed
- 46% of total program going towards preserving the existing system/facilities



IDOT Program

- 80 projects at a total cost of approximately \$1.79 billion
- 18 new projects / 62 reprogrammed
- 56 projects (76% of funds) are preserving the existing system/facilities



MODOT Program

- 206 projects at a total cost of approximately \$2.09 billion
- 42 new projects / 164 reprogrammed
- 121 projects (51% of funds) are preserving the existing system/facilities

Air Quality Conformity Determination

- Projects must be analyzed to determine conformity with air quality plans and budgets
- All projects must be included in the analysis – regionally significant projects are subject to greater scrutiny
- Projects not included in the analysis can not progress toward implementation
- Current analysis is ongoing – will be completed by late June 2024
