CALL TO ORDER

The Board of Directors meeting was called to order by Mayor Jones, Chair, with roll call attendance.

APPROVAL OF MINUTES OF THE APRIL 24, 2024 MEETING

Motion was made by Mr. Kern seconded by Mr. Elam, to approve the minutes of the April 24, 2024, meeting. Motion carried, all voting aye.

DISCUSSION ITEMS

Draft Gateway to Safer Roadways: Saint Louis Regional Safety Action Plan

Shawn Leight and Joanne Stackpole provided the board with the draft Comprehensive Safety Action Plan, named Gateway to Safer Roadways: Saint Louis Regional Safety Action Plan (Action Plan). This plan covers the entire eight-county region and will enable any county or municipality in the region to apply for SS4A's Planning and Demonstration Grants. Mr. Leight requested that comments on the draft be submitted by June 10.

Mr. Leight gave a brief background on the plan's development. The Council had applied for and received a planning grant to develop a Comprehensive Safety Action Plan for the St. Louis region through the U.S. Department of Transportation's (USDOT) FY 2022 Safe Streets and Roads for All (SS4A) program as part of the Infrastructure Investment and Jobs Act. The Regional Safety Task Force and five county stakeholder groups worked together for the development of the Action Plan.

Mr. Leight gave an overview of the Action Plan, which aims to reduce roadway crash fatalities and serious injuries in the EWG Region by 50 percent by 2050. It includes specific strategies for Regional High-Injury Networks and for each county in the St. Louis Region. Additionally, the plan involves USDOT's Safe System Approach, reviewing safety policies at different levels, unifying branding for consistent communication, and establishing a method to measure progress.

At the June 2024 Board of Directors meeting, the staff will seek final approval of the Action Plan and a commitment to the eventual goal of zero roadway fatalities and serious injuries by setting the target of 50 percent reduction in roadway fatalities and serious injuries by 2050. After the plan is approved, projects that align with the plan will be eligible to apply for funding through the SS4A program.

FY 2024 Reasonable Progress Update

Ms. Pawlak provided a brief background of the Reasonable Progress policy, how it applies to local sponsors, and an update on current project sponsors. East-West Gateway's Policy on

Reasonable Progress ensures local projects maintain their proposed schedules. Projects in the Transportation Improvement Program (TIP) are considered to have made "reasonable progress" when the federal funds programmed for the project are obligated in the fiscal year they are programmed. Failure to meet this policy will result in the loss of federal funds. Ms. Pawlak noted that project sponsors may request a one-time extension. The project extension process takes place each June and will be presented to the EWG Board of Directors for consideration and approval.

Ms. Pawlak noted that as of April 30, 2024, there are 169 local projects in Missouri with federal funding programmed in FY 2024 of the FY 2024-2027 TIP. These projects, sponsored by 51 different agencies and representing \$138 million in federal funds, are subject to the September 30 deadline unless noted as already receiving a schedule extension from the prior FY. In April 2024, the Board of Directors approved a temporary measure to increase funding for projects that are experiencing inflationary issues. To date, no adjustments have been made.

FY 2024-2027 Transportation Improvement Program – Summary of Local Project Recommendations

Rachael Pawlak, EWGCOG, provided the board with an update on Congestion Mitigation Air Quality (CMAQ) and Carbon Reduction Program (CRP) project applications. Council staff conducted a call for applications on November 3, 2023, for the CMAQ and Surface Transportation Block Grant Program – Suballocated (STP-S). The CRP funding as part of the CMAQ solicitation and Missouri Off-System Bridge Program/Bridge Formula Program (BRO/BFP) funding as part of the STP-S solicitation. The project applications were due on February 8, 2024.

A total of 32 applications were received from Illinois requesting \$25 million in federal funds and 82 applications in Missouri requesting \$174 million. EWG staff have completed the evaluation of local project applications, and the Transportation Planning Committees (TPC) in Illinois and Missouri made funding recommendations during their May meetings. More details can be found in Appendix A of the May EAC Memo.

The recommended projects will be included in the draft FY 2025-2028 TIP which will be presented to the EAC and Board of Directors in June. Following will be a public comment period from June 28 to August 1 and open houses in July. The final FY 2025-2028 TIP will be presented to the EAC and Board of Directors in for approval during their August meeting.

ACTION ITEMS

Illinois CMAQ Program - Approval of Surplus CMAQ Funding

Marcie Meystrik, EWGCOG, presented the board with the Illinois Transportation Planning Committee (IL TPC) project recommendations for the 2025-2028 Transportation Improvement Program (TIP). Ms. Meystrik noted that each of the county-level TPCs and the full IL TPC voted to recommend the approval of a temporary measure to use a \$2 million surplus of CMAQ funds on existing CMAQ projects. The funds would be divided evenly between St. Clair and Madison counties to offset project cost increases on CMAQ projects that have been stalled due to funding issues.

Ms. Meystrik then provided an overview of the parameters for the allocation of the surplus CMAQ funds. These parameters included that funds will only be applied based on contractor bids, are only available for projects previously approved for CMAQ, and can only be used for construction within the project application's scope. Additionally, the increase would be based on the federal matching percentage provided by the sponsor in the TIP application.

The funding for Madison County and St. Clair County is allocated on a first-come, first-serve basis with certain stipulations. For Madison County, the additional fund provision ends when \$1 million is committed, and in case of multiple projects on the same letting, the funds would go to the oldest approved project. Their construction funds must be obligated by December 31, 2024. In St. Clair County, the \$1 million additional funds provision also ends when the funding is committed, with a maximum of \$500,000 per project. Similar to Madison County, in the event of multiple projects the funds would go to the oldest approved project. Their construction funds must be obligated by December 31, 2025.

Staff recommends the adoption of the recommendation by the Illinois Transportation Planning Committee to apply \$2 million of surplus CMAQ funds (\$1 million to be used in Madison County and \$1 million to be used in St. Clair County) to approved CMAQ projects that have been stalled due to cost increases. The funds would be allocated according to the parameters outlined in the memo.

Motion to recommend board approval of staff's recommendation was made by Mr. Kern, seconded by Mr. Mosley. Motion carried, all voting aye.

Modifications to the FY 2024-2027 Transportation Improvement Program (TIP), Connected 2050, and the Related Air Quality Conformity Determination

Alex Hartig, EWGCOG, informed the board that the Illinois Department of Transportation (IDOT) and the Missouri Department of Transportation (MoDOT) have requested to amend the FY 2024-2027 Transportation Improvement Program (TIP), Connected 2050, and the related Air Quality Conformity Determination. In all, they are requesting to add four new projects and modify three projects. IDOT requested to add three new projects and modify two, and MoDOT requested to add one new project and modify one. Mr. Hartig gave a brief overview of the requests, which can be found in the memo.

Staff recommended that the FY 2024-2027 TIP, Connected 2050, and related Air Quality Conformity Determination be revised to add four new projects and modify three projects. These projects are exempt (40 CFR 93.126), not regionally significant, or regionally significant with respect to air quality in accordance with federal regulations. The regionally significant project (TIP# 6109A-21) is included in the most recent Air Quality Conformity Determination.

Motion to recommend board approval of staff's recommendation was made by Ms. Geisman, seconded by Mr. Kern. Motion carried, all voting aye.

Regional Security Expenditures

Samantha Lewis, EWGCOG, provided the board with four requests to expend funds in support of regional security that will improve the region's disaster preparedness and response capabilities. Funding will come from the U.S. Department of Homeland Security's Urban Area Security Initiative (UASI) grant program as well as STARRS Hospital Donation funds.

The requests total \$303,745 and are not to exceed \$295,495 from the UASI grant program and \$8,250 from STARRS Hospital Donation funds. The requests are as follows:

- The renewal of FirstNet services for seven mobile phone devices and 13 hotspot devices for 24 months for the St. Louis Fusion Center from AT&T Mobility FirstNET of Carol Stream, IL, in an amount not to exceed \$22,000.
- The purchase of 24 months of services for the six FirstNET mobile devices utilized by STARRS Staff from AT&T Mobility FirstNET of Carol Stream, IL, in an amount not to exceed \$8,250.
- The purchase of quantity twenty Avon FM54 respiratory equipment masks for the Franklin County Sheriff's Department from Con10gency Consulting of Selma, TX, for an amount not to exceed \$38,495.
- The purchase of two Thermo Scientific Gemini chemical identification analyzers for the City of St. Louis Fire Department and St. Clair Special Emergency Services Association from Thermo Scientific of Tewksbury, MA, for an amount not to exceed \$235,000.

Motion to recommend board approval of staff's recommendation was made by Mr. Brinker, seconded by Mr. Schwind. Motion carried, all voting aye.

OTHER BUSINESS

Chair Ms. Jones thanked everyone who could attend the Save Lives Now! Kick-off meeting and initiated a discussion regarding addressing the region's unhoused population. The board discussed existing and potential initiatives, with plans to introduce an approach for the effort and a regional summit at the upcoming board meeting in June.

Jim Wild, EWGCOG, provided a brief update on the *Save Lives Now!* Advisory Council which met for the first time last week on May 23, 2024 at the Florissant Valley Branch of the St. Louis County Library. Mr. Wild noted that he would be sending out the meeting documents, presentation, and media clips later that week. The next meeting will be held in late August, 2024, exact date to be determined. Mr. Wild noted that EWGCOG has initiated the search for a Director for the program. The SLN! Implementation team is overviewing the search, and applicants will be vetted by a review committee.

Mr. Wild noted that it has been nearly 20 years since the agencies bylaws have been review, the last review was held in 2005. When the topic was previously brought up it did not align with the process set out in the bylaws and was a delay in census data necessary for the review.

Motion to allow the Chair to appoint a committee to review the EWGCOG bylaws was made by Mr. Brinker, seconded by Mr. Elam. Motion carried, all voting aye.

Mr. Wild announce the retirement of two long-serving EWGCOG staff members, Dee Wellman, who served the agency for 45 years, and Joyce Collins-Catling, who serve the agency for 17 years. The board expressed gratitude for their dedicated service.

Mr. Brinker raised the subject of the agency placing the United States flag in the board room and reciting the pledge of allegiance before each board meeting. After a brief discussion a Motion to recommend board approval was made by Mr. Brinker, seconded by Ms. Harris. Motion carried, all voting aye.

ADJOURNMENT

Motion to adjourn the meeting was made by Mr. Elam, seconded by Mr. Schwind. Motion carried, all voting aye.

Each year the Board of Directors adopts a Transportation Improvement Program (TIP) that allocates federal funds to transportation projects. The program comprises the first four years of projects and strategies in the regional long-range transportation plan. Before a project is eligible to receive federal funds, it must be included in the TIP.

The draft FY 2025-2028 TIP has been developed using priorities, procedures, and policies approved by the Board of Directors through the adoption of the long-range transportation plan. Staff have worked with project sponsors, funding agencies, and advisory committees to develop the recommended program of projects.

Total Program Summary

The draft TIP contains 857 new and previously programmed projects totaling \$6.05 billion. The majority of these projects (688) are currently programmed in the FY 2024-2027 TIP and are presented for "reprogramming." With some adjustments, due primarily to revisions in project cost estimates and schedule modifications, all of the projects proposed by sponsors to retain their program status are recommended for reprogramming.

IDOT Program Summary

The Illinois Department of Transportation (IDOT) program was released on Friday, June 14, 2024. The proposed program contains 80 projects at a total cost of \$1.79 billion. This includes 18 new projects and 62 reprogrammed or rescheduled projects.

IDOT's total program designates 76 percent of the program for preserving the existing system. Fourteen percent of IDOT's funding will go to projects that add capacity to the system and six percent will address operational and safety needs. The remaining funds allocated for 'Other' includes projects such as surveys, district wide preliminary engineering, tree mitigation, and sidewalk improvements.

MoDOT Program Summary

The Missouri Department of Transportation's (MoDOT) proposed program contains 206 projects at a total cost of \$2.09 billion. This includes 164 reprogrammed or rescheduled projects and 42 new projects. Road and bridge projects sponsored by MoDOT have been reviewed and are included in the draft TIP as submitted.

MoDOT's total program designates 50 percent of the program for preserving the existing infrastructure. Thirty-one percent of MoDOT's funding will go to projects that add capacity to the system and 14 percent will address operational and safety needs. Payback projects comprise three percent of the program and include projects such as the I-64 reconstruction, New Mississippi River Bridge, and Safe and Sound Bridge Program. The remaining one percent is allocated for 'Other' projects such as future ADA transition plan improvements.

MoDOT's program includes 123 scoping projects. MoDOT's scoping policy ensures projects have defined scopes and construction costs before they are committed to the TIP. If revenues increase and construction funding is available, scoping projects may be added to the TIP as new projects in the future.

Transit Program Summary

In Missouri and Illinois, 211 transit projects (180 reprogrammed and 31 new) were submitted for programming. The total cost of the transit projects is \$1.3 billion.

Bi-State Development/Metro's proposed program consists of 83 projects at a total cost of \$1.2 billion. The program submitted by the Madison County Transit District contains 45 projects at a total cost of \$81.3 million. The majority of funding in Bi-State Development/Metro's and Madison County Transit District's programs comes from Federal Transit Administration Section 5307 funds.

The other 83 projects in the transit program (\$15.9 million) are sponsored by not-for-profits and other transit agencies. The program includes projects funded through the Section 5310 Program (Enhanced Mobility of Seniors and People with Disabilities).

Summary of Local Programs

The Missouri and Illinois Transportation Planning Committees made recommendations on new locally sponsored projects in May. The recommended projects were presented to the Executive Advisory Committee and the Board of Directors for their consideration prior to inclusion of the projects in the draft TIP.

The proposed local Illinois program contains 140 projects (114 reprogrammed and 26 new) at a total cost of \$251.5 million. The 26 new projects account for a total cost of \$36.4 million (\$28.5 million in federal funds).

The proposed local Missouri program contains 220 projects (168 reprogrammed and 52 new) at a total cost of \$625.4 million. The 52 new projects account for a total cost of \$188.7 million (\$131.9 million in federal funds).

Fiscal Constraint

The TIP is required to be fiscally constrained, with reasonable assurance that funds will be available to implement the proposed projects in a given year. Staff has evaluated the federal funds programmed in the TIP regarding amounts authorized in federal legislation and

anticipated federal spending limitations. The proposed federal funding levels for the entire program do not exceed the funds anticipated to be available in the various program years.

The state DOTs, transit agencies, and local sponsors have incorporated inflation factors into the cost estimates for their projects that are expected to be implemented beyond the first year of this TIP. Further, each of the local implementing agencies has submitted written certification indicating that non-federal matching funds are available for their respective projects. In this way, there is some assurance that proposed projects represent true commitments on the part of local agencies rather than project "wish lists."

Air Quality Conformity Analysis

Since the St. Louis region is designated as a non-attainment area for air quality, the TIP must be analyzed to determine its conformity with air quality plans and objectives. This analysis is ongoing and expected to be completed in June 2024.

Public Participation

The public comment period begins June 28, 2024 when the TIP and Air Quality Conformity Determination documents are posted to the East-West Gateway website and will close August 1, 2024. The documents will also be available at five public open house meetings in July, which are listed below. All open houses will be held from 4:30-6:30 pm. Staff and project sponsors will be available to answer questions about the TIP and Air Quality Conformity Determination during the open house meetings.

Subject: St. Louis Regional Hazard Mitigation Plan for Missouri Counties

Date: June 13, 2024

East-West Gateway Council of Governments has begun work on the 2025-2030 St. Louis Regional Hazard Mitigation Plan (HMP) for the five Missouri counties. The HMP addresses actions that local governments, school districts and special districts can take prior to a natural disaster to reduce impacts and prepare residents to respond effectively.

The HMP will present information about natural disasters, levels of risk, and strategies for local jurisdictions and school districts to take to reduce the adverse effects of natural hazards including tornados, severe thunderstorms, severe winter or summer weather, drought, flood, earthquake, dam failure, or wild fire. The HMP will include a summary of natural disasters in the last five years, mitigation actions local jurisdictions have taken during that same time, and recommended priority actions for the next five year period. Participation in the plan is voluntary, but is necessary if a jurisdiction plans to pursue federal hazard mitigation funding.

To provide guidance with the plan update, EWG is creating a Working Group of the five county emergency managers or their representatives, a representative of the school district cooperative Education Plus, a representative of the STARRS and the COAD (Community Organizations Active in Disasters) committee. The Working Group will provide advice to staff, assist with engagement of local jurisdictions regarding completion of an informational questionnaire, and provide input and feedback on the draft plan.

The State of Illinois uses a different planning process and each county is responsible for developing its own HMP. Through STARRS and the COAD committee, EWG will seek to enhance communication and coordination of planning among the counties in the two states.

Subject: Missouri Arterial Study

Date: June 13, 2024

In April, 2023 East West Gateway, in partnership with MoDOT staff, kicked off a study of the arterial roadway network in the Missouri side of our region. This was driven by a desire to supplement existing roadway design guidance to better address diverse and complicated conditions in urban environments. Recently completed, the tools developed are freely available to MoDOT, county, and municipal roadway planners and engineers.

The new tools include:

- The "Blueprint for Arterials" document, which includes:
 - Supplemental steps and clarification of the existing MoDOT Engineering Policy Guide (EPG)
 - o Additional tools for improving safety for all roadway users
 - Recommendations for community engagement appropriately scaled to various project types
 - Clearly defined "Typologies" for the variety of arterial roadway segments in the region
- Staff training curriculum a combination of instructional videos and in-person workshop exercises.

Subject: Regional Effort to Address the Unhoused

Date: June 17, 2024

At the May meeting of the East-West Gateway Board of Directors the issue of regional homelessness and the unhoused was brought up for discussion under Other Business. During the Board of Directors' conversation it was recognized that the issue of homelessness and the unhoused affects every county in the St. Louis region and warrants a dialogue about developing a regional strategy around the issue. Staff was directed to develop an approach for the Board to consider at their June meeting.

It was suggested during the Board's conversation that a Regional Summit be held to discuss homelessness and the unhoused. As with other efforts undertaken by EWG, the approach will be inclusive and data driven. Staff will work to identify a broad range of sectors to be involved in the effort including government, business, social services, housing experts, schools/universities, health and mental health experts, and peer communities.

Topics that will be considered when preparing for the summit, and follow-up to the summit include: Inventory of what is being done locally; identifying regional partners; engaging peer cities/regions to determine how they addressed the homelessness and the unhoused; collaborate on data sharing; and have conversations with elected officials, business leaders, and subject matter experts to collect their insight into the issue. A target date for the summit is late Fall 2024.

In addition to conducting a summit the approach should also include a convening of experts from peer regions/communities across the country that are taking on the challenge of homelessness in their communities. The purpose of the practicum would be to develop a strategy of best practices that can be utilized in the St. Louis region.

Staff Recommendation:

Staff recommends that the Board of Directors authorize staff to convene a Regional Summit on Homelessness and the Unhoused and to convene a group of experts from peer regions/ communities to help provide insight into national best practices and experiences.

The Council applied for and received a planning grant to develop a Comprehensive Safety Action Plan for the St. Louis region through the U.S. Department of Transportation's (USDOT) FY 2022 Safe Streets and Roads for All (SS4A) program as part of the Infrastructure Investment and Jobs Act. The Comprehensive Safety Action Plan, named *Gateway to Safer Roadways: St. Louis Regional Safety Action Plan* (Action Plan) covers the entire eight-county region and will enable any county or municipality in the region to apply for SS4A's Planning and Demonstration Grants in 2024, 2025, and/or 2026 or Implementation Grants in 2025 and/or 2026.

The Action Plan includes the following:

- A target to reduce the number of fatalities and serious injuries caused by roadway crashes in the EWG Region by 50 percent by 2050.
- Regional High-injury Networks (All Modes, Vulnerable Road Users, Underserved Communities, Top Contributing Factors, and Interstates).
- High-injury Networks for each county in the St. Louis Region.
- Near and long-term strategies focused on USDOT's Safe System Approach, including proven safety countermeasures.
- A review of local, state and national safety polices, concepts, and resources. Identifies
 the strengths in local and state policies and programming as well as needs and
 opportunities.
- Unified branding to ensure consistent communication across the Region.
- A method to measure progress.

Staff requested comment from members of the Transportation Planning Committee, Executive Advisory Committee and the Board of Directors from May 21st to June 10th. Staff did not receive any comments during the comment period.

Staff Recommendation: Staff recommends that the Board of Directors adopt the resolution that adopts the Action Plan and makes a commitment to the eventual goal of zero roadway fatalities and serious injuries by setting the target of 50 percent reduction in roadway fatalities and serious injuries by 2050.

East-West Gateway's (EWG) Policy on Reasonable Progress is intended to ensure that projects funded though the local program maintain the schedule as proposed in the project application. In April 2010, the Board of Directors approved a modification to the one-time schedule change allowed by the Policy on Reasonable Progress. The change allowed sponsors to request, no later than June 1, a one-time extension. It gave staff authority to grant extensions up to three months and required Board action on extension requests of three to nine months.

To be considered for this one-time extension, the sponsor has to demonstrate: a) the delay is beyond their control and the sponsor has done diligence in advancing the project; b) federal funds have already been obligated on the project, or in cases that no federal funds are used for preliminary engineering or right-of-way (ROW) acquisition, there has been significant progress toward final plan preparation; and c) there is a realistic strategy in place to obligate all funds within the extended time.

Extension Requests

As of the May 28 deadline, staff received 24 requests for schedule extensions beyond the September 30, 2024 suspense date. The amount of federal funds programmed for these projects is \$35.8 million. Of the 24 requested schedule extensions, three (3) were for a three-month extension and the remaining 21 were for a nine-month extension. The remaining 48 projects with construction funds programmed in FY 2024, representing \$52 million in federal funds, are scheduled to obligate funds by September 30, 2024. For reference, East-West Gateway received 36 requests for extensions totaling \$49.5 million last year.


Three-month Extension Request






FY 2024 Project Tracking - through May 2024

Nine-month Extension Requests

Local Program Tracking

The Missouri Department of Transportation (MoDOT) now requires the Transportation Management Areas (TMA) to obligate a specific percentage of funding each year. For FY 2024, MoDOT's goal is for each TMA to obligate 120 percent of its annual allocation. A "trigger point" was also established, where if the obligation rate falls below 110 percent of the annual allocation at the end of the fiscal year, the funds will expire. The targets for FY 2024 are shown in the table below:

Attachment A provides the FY 2024 Project Tracking, through May 2024. The total FY 2024 program makes up \$138 million in federal funds. As of May 31, 2024, there have been 52 projects that have obligated funds, totaling \$36 million in federal funds. Three (3) projects have been removed by the project sponsor, totaling \$8 million. The unobligated project balance totals \$93 million in federal funds. The remaining obligation needed to achieve the 110 percent obligation rate is approximately \$63 million. The requested schedule extensions result in only \$57 million remaining to obligate in FY 2024, which is \$6 million below the 110 percent trigger point.

Staff have been working with MoDOT St. Louis district staff and local project sponsors to advance projects from outer years of the Transportation Improvement Program and has identified eight (8) projects with \$24 million in federal funds that could likely obligate in FY 2024. Staff has also identified 10 project extension requests with \$9 million in federal funds that could likely make the September 30, 2023 deadline. Staff will continue to work with project sponsors to ensure as many projects as possible will obligate federal funds in FY 2024.

Additionally, in April 2024, the Board of Directors approved a temporary measure to increase funding on projects that are experiencing inflationary issues. There is \$10 million available to use for this measure. As of May 31, 2024, two (2) projects, with a total of \$393,980 federal funds, have been pre-approved for the inflationary cost increase. The projects have not received Bid Concurrence from MoDOT yet, which means the funds have not yet been obligated.

Staff Recommendation: Based on the existing Policy on Reasonable Progress, and the information provided by local project sponsors, staff recommends that the 21 projects identified in **Table 2** be granted a nine-month extension to the September 30, 2024 suspense date. Federal funds for these 21 projects must be obligated no later than June 30, 2025.

East-West Gateway staff have been working closely with MoDOT and local project sponsors to estimate the region's obligations for this fiscal year. Unfortunately, there have been some local projects that have dropped and there were more schedule extension requests than anticipated causing staff to question whether enough funds will be obligated to avoid local funds expiring.

Staff is asking to amend these projects into the current TIP to provide a buffer against potentially lapsing LPA funding due to not meeting the minimum 110% obligation target set by MoDOT for this fiscal year. These transit projects can be transferred from FHWA to FTA, which will constitute the obligation of \$10.7 million, before the end of this fiscal year. This should provide an adequate buffer so that the region will not lose any local funds this year.

Staff Recommendation: Staff recommends that the FY 2024-2027 TIP, *Connected 2050*, and related Air Quality Conformity Determination be revised to add five new projects and modify one project. Staff is requesting authorization to expend funds in support of regional security that will improve the region's disaster preparedness and response capabilities. Funding will come from the U.S. Department of Homeland Security's Urban Area Security Initiative (UASI) grant program. Attachment A summarizes the purchases, totaling \$250,200.

ST. LOUIS FUSION CENTER:

CLEAR PRO Renewal – In May 2023, the Board authorized EWG to purchase a two-year renewal of the Fusion Center's subscription to the CLEAR PRO online investigation software. The CLEAR PRO system quickly gathers real-time and historical data for investigators from many sources, helping create a comprehensive view useful in investigations. The cost for the second year of the license renewals for eight (8) users, which includes Law Enforcement Investigator Plus licenses and Criminal Justice License Plate Reader (LPR) technologies, increased by \$350 per month, and therefore additional funds are needed for the renewal of the software from West Publishing / Thomson Reuters. The total additional cost will not exceed \$4,200.00 from the UASI grant program.

REGIONAL CYBERSECURITY INITIATIVE:

Recorded Future Renewal – Staff is seeking the 12-month renewal of four (4) software licenses for the Recorded Future cybersecurity intelligence software for use by the Regional Cybersecurity Coordinator and Analyst, as well as other investigators and analysts in support of the Regional Cybersecurity Initiative. The software provides cybersecurity related intelligence and analysis of a unique nature to include threat, brand, vulnerability and geopolitical intelligence. The total cost of the software licenses from Carahsoft Technology Corp will not exceed \$138,500 from the UASI grant program.

DOMESTIC VIOLENT EXTREMISM:

CobWebs Renewal - Staff is seeking the renewal of the Cobwebs online threat identification, social media analyst, and alerting tool for use by the Regional Cybersecurity Coordinator and Analyst, as well as other investigators and analysts, in support of the Homeland Security Grant Program's Combating Domestic Violent Extremism priority area, which is a required priority area by the U.S. Department of Homeland Security / FEMA in the UASI grant. The Cobwebs platform allows the Fusion Center personnel to identify online threats and threat actors and contributes to the exchange of investigation information and capabilities with Fusion Center peers. The three software (3) licenses, in addition to dark web monitoring access will be renewed for a 12-month period. The total cost of the renewals from Penlink, Ltd. will not exceed \$107,500 from the UASI grant.

STAFF RECOMMENDATION:

Staff recommends that the Board approve the expenditure of funds as follows:

- for the additional costs associated with CLEAR PRO license renewals from West Publishing / Thomson Reuters of Eagan, MN in an amount not to exceed \$4,200;
- for the renewal of four (4) Recorded Future software licenses from Carahsoft Technology Corp of Reston, VA for an amount not to exceed \$138,500;
- for the renewal of three (3) CobWebs software licenses and dark web monitoring access from PenLink, Ltd. of Lincoln, NE for an amount not to exceed \$107,500;

for a total amount not to exceed \$250,200 from the UASI grant program.
