

### Promise of a Regional Approach

- 1. We will not just move the needle on homelessness, we are going to solve homelessness for the region.
- 2. We will build a system of care to ensure no one has to sleep on the streets and everyone is provided the supports they need to stabilize and enhance wellbeing.
- 3. We will be accountable for making progress by {doubling, tripling} the number of households we help exit homelessness and stabilize in housing.



## Promise of a Regional Approach



4. We will take our system of care right to the streets and assist individuals to move directly to housing with the wrap-around supports they need to recover.



5. We will support our nonprofit service providers to hone their services, allowing each to focus on their core strengths in partnership with other partners in the region's system of care to deliver the full complement of services needed to solve homelessness.



6. We will be effective stewards of regional resources, consolidating functions to reduce redundancy, scaling effective solutions, and working with partners across sectors to leverage all available resources.



7. We will unite public institutions and private funders to raise the additional funds to build our comprehensive system of care.



# Promise of a Regional Approach

- 8. We will ensure our regional system meets the needs of local jurisdictions, calibrating our investments and wielding centralized services to ensure the whole region succeeds together.
- 9. We will seek sustainable funding to ensure we do not backslide, solving homelessness for the region is about building a sustained system of care to meet the needs of anyone facing imminent homelessness.
- 10. We will support the region to expand solutions to making housing attainable, growing the housing stock and making existing housing more accessible.


### Roadmap for Uniting & Organizing the Region

- Socialize and identify ways to catalyze regional transformation.
- Create a collective impact governance structure comprised of regional governments, philanthropy, business leaders, and regional coordinating entities.
- Test our theories in micro across the region and commit to an initiative that builds our regional system of care and amplifies rehousing.
- Functionally unite the homeless service systems of our counties to create coordinated entry and exit and centralized data management for our regional system care.
- Determine the necessary regional investment to create and sustain a regional system of care that solves homelessness across the region.
- Assemble the funds and calibrate investments to elevate each jurisdiction's impact while leveraging shared regional services.

#### Identify Anchor Organization by Spring 2025 We will:

• Define and Empower an Anchor Organization: Select a leading organization that is trusted across the region and well-positioned to drive the initiative forward.

#### Identify Backbone Organization by late Spring 2025

We will:

• Establish coordinating entities will act as bridges between the Steering Body and on-the-ground efforts, serving as facilitators, translators, and connectors.



#### **Create Steering Group for Funding**

We will:

• Work with regional funding groups being led by GSL, HESTL and government to create Housing First Funding Initiative.

#### **System Data Collection**



We will:

 Work with all 7 CoCs towards a system of data collection to build out metrics for next steps.

#### **Create Steering Group for Housing**

We will:

• Develop a centralized, coordinated housing and rehousing system to manage and expedite housing placements.

#### **Create Work Groups**

We will:



• Work groups will focus on specific areas such as policy development, service delivery innovation, housing access, and community engagement. These groups will include service providers, technical experts, and individuals with lived experience who work together to test and shape policies and practices that build the regional system of care.

#### **Public Engagement Forums**

We will:

• Hold regular public forums where community members can engage directly with the steering committee.
